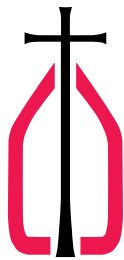

For close to 100 years, Catholic Charities has provided help and created hope in households and communities across the Archdiocese. Our programs are far-reaching and transformative, including behavioral health, family strengthening, school readiness, migration and refugee services, and many more.

In everything we do, our actions are guided by the conviction that every human being deserves dignity and respect, with special care and attention to how the most vulnerable members of our society are faring. Sometimes, the circumstances of becoming vulnerable arrive with little to no warning.

In September 2017, the devastating effects of Hurricane Maria caused many to seek help and shelter far away from their homes. Not long after families began to arrive in Connecticut seeking refuge, Catholic Charities joined a coalition of other organizations to deliver a compassionate and professional response. We provided basic needs such as groceries, clothing, and assistance in the search for housing. We helped with employment searches, bus passes, and school enrollment. We provided security deposits, rental assistance, and school uniforms. By February 2018, Catholic Charities had served over 2,600 individuals relocating to Connecticut from Puerto Rico and the U.S. Virgin Islands. We continue to support these families as they settle into our communities.

None of our work would be possible without the kindness and caring of every single individual and organization acknowledged in this annual report. We are so grateful for your generosity and honored by your partnership. Thank you for your past support of Catholic Charities, and thank you for joining us in 2019 as we move one year closer to celebrating a century of service to others.

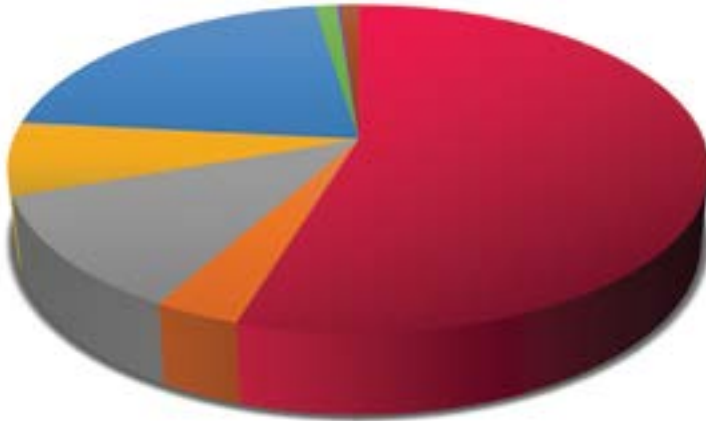

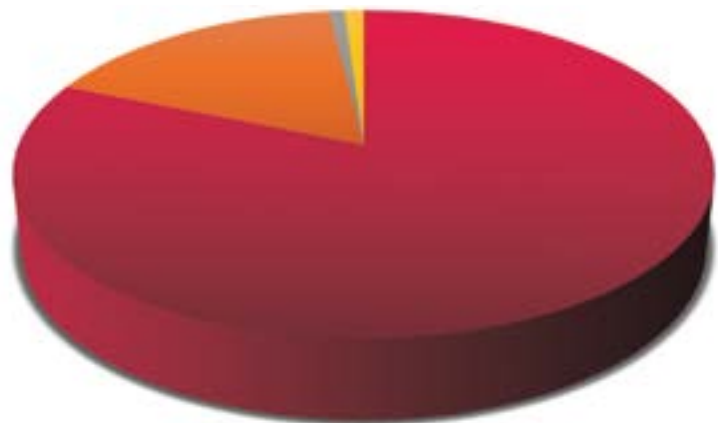

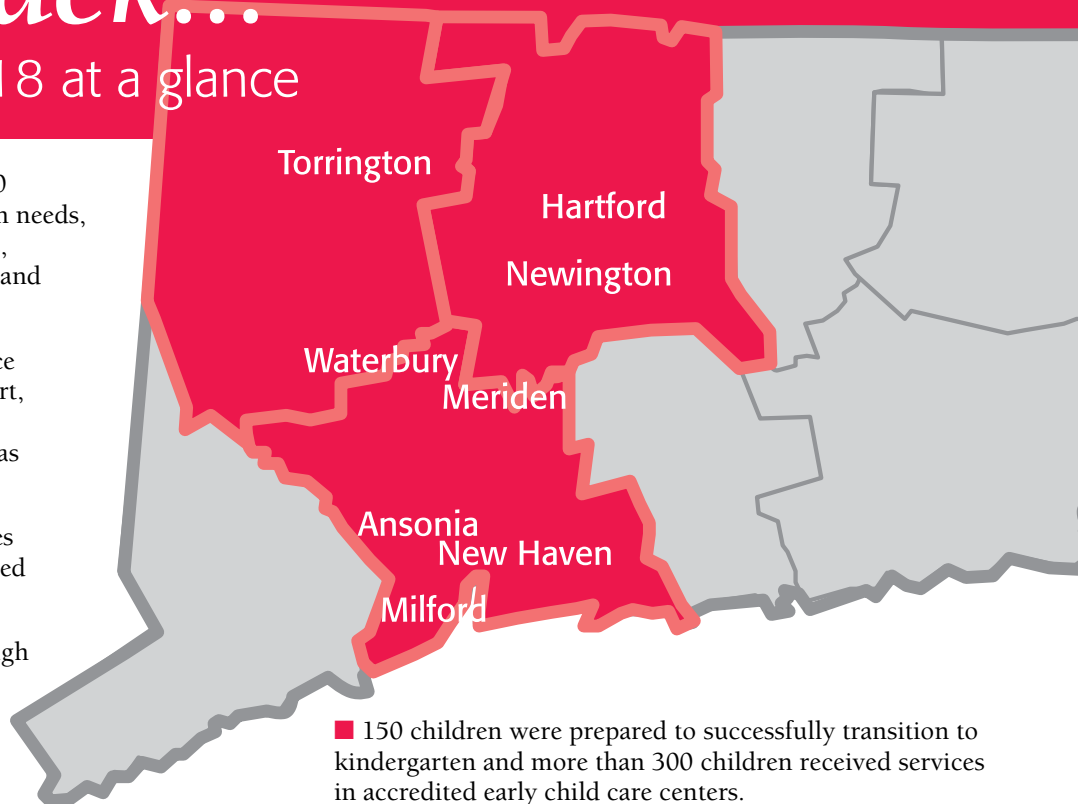

A look back...

Fiscal year 2017-2018 at a glance

- Family Centers served more than 6,000 individuals and families with basic human needs, family strengthening and literacy services, parenting education, leadership training, and early childhood support for families.
- The Archbishop's Emergency Assistance Fund provided basic human needs support, information, and referrals to over 200 individuals and families. Over \$80,000 was distributed in direct assistance.
- 280 seniors received supportive services through our senior centers and home-based programs.
- 150 individuals received support through our adoption program to facilitate searches for relatives or child placement.
- 84 refugees were resettled in the Hartford area while hundreds of other refugees who were resettled in prior years continued to receive support.



- 150 children were prepared to successfully transition to kindergarten and more than 300 children received services in accredited early child care centers.
- Over 600 at-risk youths from Hartford and New Haven received comprehensive services, including afterschool and summer programming, case management, employment skills training, and school-based programs.
